HSD-03/2010/69 Dated 15.06.2010: In pursuance of order No.DS-76/2010/1 dt.25.05.2010 received from the Director, FCS&CA, Assam, Guwahati, the following quantity of Wheat atta (M/S UFM Industries= Atta-600.00 Qtls Bran-30.00 qtls, M/S Harlalka Mfg Industries=Atta-1300.00 Qtls Bran 30.00 qtls and M/S Radhakrishna FL.Mill= Atta-400.00 Qtls Bran 20.00 qtls)(Total atta 2300.00 qtls and bran 80.00 qtls.) is hereby sub-allotted to the FP Shop dealers of this Sub-Division out of **May/2010 quota APL wheat**.
