In pursuance of WT message No.DS-159/2009/6 dt.09.12.09 and No.DS-159/2009/17 dt. 15.02.10 received from the Director, Food, Civil Supplies and Consumer Affairs, Assam, Guwahati and this office order memo No.HSD-07/2007/308 dt.14.12.09, No.HSD-4/2010/22 dt 18.02.10 an adhoc/additional allocation of 6982.50 qtls atta and 294 qtls bran out of 7350 qtls Wheat lifted on account of drought relief measures for the month of Oct/09 to Feb/10 for distribution through nominees/allottees to eligible APL/BPL families as drought relief measure is hereby allotted to the following FP shop dealers as shown below. The ex-Mill price of the atta should not exceed Rs.1238.76 per qtl as per PDS norms. Retail sale price of atta 13.20 per qtl.

The last date of lifting of whole meal atta from cocerned Modern Chakki Mill is valid upto 30.06.10. Distribution quantum to be fixed by the dealer as per demand of the consumers. (@ 8.82 kg/head)
