While conducting the enquiry, the team will follow the following guideline/instructions:

- 1) They will inspect all relevant records/documents regarding lifting and distribution of all PDS goods like BPL/AAY/APL/MDM Rice, Levy Sugar, Blue Dyeil S.K. Oil, APL Wheat/ Whole Meal Atta etc.
 - 2) Verify copies of monthly allocation received from Govt. and others.
 - 3) Verify copies of RO issued by the FCI authority for each item for each month.
 - 4) Verify stock register of Sub-Wholesalers/GPSS and lifting and delivery account to F.P. Shop/ Agents by them.
 - 5) Verify stock register etc. at F.P. Shop/ Agents level.
 - 6) Compare the month wise issue of PDS/TPDS items to APL/BPL/ AAY beneficiaries with monthly allocation.
 - 7) Suggest punitive measures against such defaulting agencies/licence holders including filing of FIR against such defaulters.
 - 8) Regular Checking in all LPG distributors, hotels, restaurant, dhabas etc. in both urban and rural areas of Bilasipara Sub-Division to detect possible diversion of LPG Cylinder and unauthorized issue and to take appropriate action against the involved Firm/Person.
 - 9) Keep strict vigil and check the price and unauthorized stock of essential commodities in the open market.
 - 10) Fortnightly Return/Reports in the above matter is to be submitted to this Office for onward submission to the Govt. on regular basis.
- In case of necessity, the S.D.P.O. Bilasipara will provide security to the teams as and when requested by the team leader.

The undersigned will supervise and monitor the whole process.
