

IMPLEMENTATION OF "AAMAR DUKAN" SCHEME IN RESPECT OF DHUBRI SUBDIVISION.

Altogether, 126 (one hundred twenty six) nos. of "AAMAR DUKAN" have been set up in Dhubri Sub-Division so far covering the entire sub division. Out of above, 14 nos have been opened in urban areas of Dhubri and Gauripur Town. The rest 112 nos have been opened in rural areas attached to GPSS under this sub division.

The formal inauguration was done on 01/01/2011 by Deputy Commissioner with one such shop in Ward No 1 of Dhubri town amidst a distinguished gathering of the locality including leading citizens and journalists who also addressed the gatherings.

General instruction has also been given to all shop owner to keep the stock of some other essential items like Jinger, Garlic, Green chilly, Onion, Potato and other seasonal green vegetables after procuring from rural areas at "Aamar Dukan" besides the specified open market commodities.

Item wise prices have also been fixed @ Rs.2/- less per Kg. per items than the prevailing open market price by convening meeting with the members of local Chambers of commerce and others for sale at Amar Dukan for Dhubri subdivision.

The unique features of such shops with identical banners with writing in red ink with yellow back ground with the theme "Jago Grahak Jago" has made it easily identifiable even amongst illiterate people. Strict instructions have been issued to all of such shop owners for compulsory display of price and stock. Besides, priority has been given to persons having FP shops in opening "Aamar Dukan" so that poor and needy can get the PDS/TDPS goods along with other essentials goods at comparatively low price than in the open market in the same shop premises without much effort.

Wide publicity has been given through FLS and other media for creating awareness amongst the general public about the functioning of such shops. As per feedback received so far, newly venture is getting good response from the public in different localities which if properly managed with close monitoring by FCS & CA officials will be an economically viable scheme which will help the common people particularly the poorest section of the society with some source so far prices of essential commodities are concerned.

Shri N.F.H.Hussain, Addl. Deputy Commissioner, FCS& CA,Dhubri has been notified as Nodal Officer vide this office No. DSG-123/2010/59 dated 22.11.2011 in connection with expeditious implementation and to review the innovative scheme "Aamar Dukan" with selected F.P.Shops/Local Chamber of Commerce/ Stockist/Distributors/Wholesalers of the open market commodities and FCS&CA Officials in the light of Govt. instruction vide W.T.Message No. DS 198/2010/15 dated 20.07.2011.


